Board of Directors Meeting February 27, 2019 Minutes of the Meeting

A meeting of the Board of Directors was convened by Dr. George Kafkoulis, the corporation's President, in Miami, on Wednesday, February 27<sup>th</sup>, 2019. The following Directors were present: Chairman Dr. George Kafkoulis; Mrs Catherine Hernandez; Dr. Andres Tremante; Dr Solange Kouemou; Mr. Nikolas Monocandilos; Corporate secretary Mr. Frank Berrizbeitia who kept the minutes. Also in attendance was the CEBO Mr Dimitri Bardoutsos and Mr George Katsoufis.

Meeting called to order at 7:42 pm.

The minutes of the previous meeting January 30,2019 were read and approved unanimously.

The Chairman gave a brief summary of his meeting with Dr..Martha Perez -School Board member of the MDCPS who told him that the Archimedean Public Charter School teachers were not scheduled to receive any supplements approved by the voters. The Chairmen then outlined a three pronged campaign to pursue the funds being disbursed by Referendum 362 approved by MIAMI-Dade County voters in November 2018 and which in the Archimedean Board's opinion is rightfully due to our teachers as Public school employees.

- 1. Approve a 5% supplement to the salaries of all Archimedean teachers retroactive to January 1,2019 as a teacher retention supplement based on their current plain base salary and enlist their support in securing the negotiated increase that was approved for all public MDCPS teachers effective July 1,2019.
- 2. Contact the directors of Charter School Alliance as well as Attorney Arza of the Charter school governing body of the MDCPS.
- 3. Engage the community and follow closely the lawsuit instigated by the Charter School alliance against the Palm Beach County Public School Board for having passed a resolution that discriminates against Charter Schools and charter school teachers.

The chairman proposed a resolution to provide a 5% salary supplement based on the current Archimedean Teacher's scale. Said increase to be retroactive to January 1st 2019 till June 30th 2019. Said resolution was approved by the Board by a 5 to 1 vote. Furthermore, the Board tabled further discussion on any proposed increases or supplements to be applied to the Teacher's income after July 1,2019 since no funding has been approved for the next Fiscal year as of this date by either Tallahassee nor the MDCPS SUPERINTENDENT and Board of Directors.

The Board was appraised of the 5 K /1 K run walk and all Board members were requested to participate or sponsor a student.
