Minutes of May 27, 2020 were unanimously approved.

Board undertook a discussion of the negotiation with Ziegler for the refinancing for the Archimedean Academy, LLC. The structure of this financing would include the acquisition of 100% interest of the Archimedean Properties LLC; refinancing of the Regions loan; and capitalization of property improvements (Cafetorium, Gymnasium, etc.). Proposed rate is

between 3.75- 4.25 with 100% loan to value, no appraisal and no reserve account required. A three part motion was set forth by Mr. Haralambides:

These Motions were approved unanimously.

There is no new information from the auditors in the review of the 2019 financial records. Dr. Kafkoulis clarified a deadline of Friday June 12 given to the accountant to complete a review of financial statements.

In a review of the legal case regarding Ref #362, Dr. Kafkoulis reported that Judge Areces ruled in favor of Archimedean Schools against MDCPS. The City of Aventura has joined the Archimedean Schools in this case.

Dr Kafkoulis presented a preliminary review of the FY 2020-2021 budget. Due to a delay in the release of the Florida budget, the current expectation is that funding from Tallahassee will be flat for the next two years which will impact the development of the FY 2020-2021 budget. A full review of the budget will be available at our June 24th meeting.

The Vice President submitted a proposed resolution that was seconded by Dr. Kafkoulis and Board member Mrs. Hernandez outlining the By-laws as stated in our Articles of Incorporation and this was approved unanimously.

The Chairman then requested that we approve the MDCPS school calendar 2020-2021 with the proviso that Dr. Kafkoulis had the authority to request

any adjustments or modifications if he saw fit for the smooth running of the Archimedean Schools.

There was a third resolution adopted for the disbursement of the Best and Brightest * award and these were all approved by the majority of the Board members present.

The Chairman also presented his five-year projections FY 2021-2025 based on certain premises and mentioned these were requested by the landlord in preparation for a future refinancing of the School's main campus. The CEBO mentioned that AA Inc. would be receiving a MOODY's rating and that this may have an impact on the interest rate to be charged. The discussions were tabled for the next meeting and to channel the information to the AUDIT committee in order to receive their assessment of these figures. The Board approved the renewal of the lease of Pre-K facility with Sunset Construction, Inc., for the period of Jun 30, 2020 through Jun 30, 2022 at the same rate as the previous four years

The Treasurer suggested that we authorize a drive-through parade at the campus for all Archimedean Schools this year to celebrate our students' accomplishments. This was approved by the board with the requirement that the PTO's organize these items and all participants remain in their vehicles and wear masks and maintain social distances.
